## HOLD-A-RUG WARRANTY

HOLD-A-RUG<sup>®</sup> is a multi-purpose non-skid rug underlay. The product is made of 100% virgin fibers needle punched together and coated with a water base pressure sensitive dry adhesive with no solvent in it. It can be used on wallto-wall carpeting or on smooth flooring surfaces.

Prior to installing HOLD-A-RUG, the floor should be vacuumed, clean and dry. HOLD-A-RUG must never be installed on a wet floor. In order to obtain a long-lasting non-skid performance, avoid frequent removal and reinstallation of HOLD-A-RUG from its designated installation area.

When installed on a smooth surface, HOLD-A-RUG may leave an inoffensive light residue made of dust, particles of dirt, fibers and resin. The residue can be easily cleaned with many common household cleaners, subject to specific floor finish/surface manufacturing guidelines.

## Our recommendations for cleaning are as follows:

Wood floors (polyurethane finish) -OrangeGlo Everyday Hard Wood Floor Cleaner -Bonakemy soap -AOS soap (soap with no solvent)

Ceramic and vinyl floors -General cleansers diluted with water

Natural stone with no sealant -Mild soapy solution

HOLD-A-RUG is guaranteed not to mar, stain, oxidize or discolor properly installed, finished and maintained floors and carpeting.

HOLD-A-RUG is safe for use on radiant heated floors installed for residential application with temperatures not exceeding 90 degrees Fahrenheit.
